2007 Pennsylvania Forest Stewards Biennial Survey

Summary Report



Brief Summary

The 2007 edition of the Pennsylvania Forest Stewards (PA Forest Stewards) biennial survey shows that PA Forest Stewards volunteers continue to actively promote forest stewardship in their communities. The number of volunteer hours reported was comparable to the number reported in the 2005 survey, with a significant number of volunteers (15.1%) not responding to our survey or phone calls. This year volunteers reached numerous of friends, neighbors, or members of the public (estimated 19,500 people). The most common outreach activity remains talking to neighbors and other woodland owners about forest stewardship. PA Forest Stewards volunteers continue to be active members and supporters of Pennsylvania's local/regional woodland owner associations: 156 PA Forest Stewards (54% of respondents) were members and 83 (29% of respondents) were board members or in leadership roles.

Survey Methods

We sent a survey form (sample on the last four pages of this report) to all of the PA Forest Stewards volunteers in the database (N=338). We sent a second identical survey form to those who did not complete the first form by the deadline, and a third identical form to those who did not respond by the second deadline. We emailed or phoned each person who did not respond to the third mailed survey and offered the option to respond via telephone. If we were unable to talk to the PA Forest Steward, we left a message asking them to call us back.

Four hundred forty-eight PA Forest Stewards volunteers have been trained since the program's inception and three hundred fifty-seven remained in the program at the start of the survey. (This number includes the new volunteers from 2007 - 19 people. These new volunteers were not surveyed this calendar year.) Although we made no attempt to contact people who were no longer involved in the program before the survey began, we do know that we have lost some PA Forest Stewards over the years when they moved out of state, sold their forestland, suffered from deteriorating health, or passed away. In 2007, we removed 13 people from the database, who said they were no longer interested in the program.

Results and Discussion

Response Rate

Of the 338 PA Forest Stewards to be surveyed in the program at the beginning of the survey period, 287 provided survey information (84.9% response rate). Separate surveys were sent to each PA Forest Stewards volunteer within a household. Several volunteers responded for themselves and their partner – this was taken into account in the reporting below.

Ownership Information

Two hundred thirty-four PA Forest Stewards respondents own forestland (81.5%). PA Forest Stewards own land in 54 out of 67 counties in Pennsylvania, as well as New York, Wisconsin, South Carolina, New Jersey, and Virginia. PA Forest Stewards own over 45,390 acres of land, of which 37,938 is forested (84%). Average parcel size for the volunteers is 208 acres.

Current Status

The survey asked PA Forest Stewards to indicate their volunteer status: active in the past 12 months; inactive in the past 12 months, but wish to remain in the program; and no longer interested (see Table 1). Two hundred sixteen (63.9%) said they were currently active. Fifty-seven (16.9%) indicated that they were currently inactive but were still interested in remaining in the program. Many of the inactive volunteers cited time limitations and health factors as reasons, but hoped to become active again in the future. Thirteen (3.8%) indicated that they were no longer interested in the program, fifty-one (15.1%) did not respond to either the written surveys or telephone calls, and one volunteer passed away this year.

Outreach

PA Forest Stewards volunteers were asked to estimate how many friends, neighbors, or members of the public they reached through their stewardship-related outreach activities. Two hundred thirty-four volunteers responded to this question with an estimated 19,500 people reached. The breakdown of responses can be found in Table 2.

Volunteer Hours

The survey also measured PA Forest Stewards volunteer hours. PA Forest Stewards were asked to provide hours for over thirty-one categories of activities on their own land and working with others to promote Forest Stewardship in the past 12 months. The hours reported is probably an underestimate, because it is likely that some of the 51 non-respondents also had volunteer hours that went unreported.

The PA Forest Stewards who did provide quantitative information collectively reported over 43,800 volunteer hours in all Forest Stewardship activities (average = 152.6 hours) reaching an estimated 19,500 people. These numbers indicate a continued high rate of involvement in light

of the initial agreement PA Forest Stewards make at the time of their training. Their commitment is limited to 40 volunteer hours in the 12 months after training; no further commitment is required. However, the active volunteers averaged over 152 hours of service in the past year alone, and many of these volunteers went through the initial training years ago.

The new volunteers (Class of 2006) were surveyed for the first time this year. Thirty-four new volunteers were surveyed with thirty-three responding. The new volunteers reported 7,529 volunteer hours in all Forest Stewardship activities (average = 228 hours).

Stewardship Activities

The survey also asked PA Forest Stewards to list their Stewardship activities. One primary objective of training Forest Stewardship volunteers is to provide them with the tools they need to effectively encourage their friends, neighbors, and other community members to become good stewards of their own lands. The most frequent PA Forest Stewards activity was talking to neighbors and other woodland owners about Forest Stewardship (see Table 4). Two hundred eleven PA Forest Stewards reported doing this activity in the past year.

The other most common outreach activities were attending forest conferences, workshops, and seminars (136), working to support an existing woodland owners association (118), distributing Forest Stewardship information (91), referrals to consulting foresters (78), and serving on Advisory Committees (49).

The most commonly cited stewardship activities that PA Forest Stewards implemented on their own properties included removing competing vegetation (134), maintaining trails and roads (133), planting trees/reforestation (122), timber stand improvement (121), and wildlife enhancement (96).

Local Woodland Owner Associations

Local woodland owner associations (WOAs) are important catalysts for promoting Forest Stewardship in Pennsylvania. Each group is independent, and most sponsor education programs, woodland tours, and newsletters to provide woodland owners with information about managing their forestlands. The "Nurturing WOAs" subcommittee of the PA Forest Stewards Steering Committee has targeted supporting existing associations, helping to make connections between strong and struggling groups, and starting new groups in parts of the state where no such organizations exist. As part of this effort, the third statewide conference for all of Pennsylvania's WOAs was held in September 2007.

One hundred fifty-six (54%) PA Forest Stewards belong to at least one local or regional WOA and sixty-seven (23%) reported that they were board members. One hundred eighteen respondents reported working to support an existing woodlands association and ten PA Forest Stewards said they were working to start new associations.

Proud Events

Again this year, the 2007 survey included space for volunteers to share their proudest activities from the past year. A smattering of results...

I led a tour at the 2007 PAFS Annual picnic with Tim Cole.

Establishing and caring for American chestnut breeding nursery; maintaining FLEP plantings; managing timber stands and sale; managing farmland use; working with conservation agencies.

Staffing the Woodland Owners Association table at Ag Progress, TSI on my property and at hunting club property in Lycoming, certification as Tree Farm, work with WOCC

Working for PFA at Farm Show

Over the last 3 years I have planted many native shrubs on the banks of Turtle Creek in Pedora Park. This is a very small stretch of Turtle Creek but now Public Works does not mow down to the water's edge anymore! I have also planted shrubs and trees along Turtle Creek in Duff Park

I spent a considerable amount of time discussing the benefits of the FSP and conservation easements with my sister. She ultimately enrolled her 130 acres in Luzerne Co in the North Central Conservancy

Continuing my efforts to donate an easement to the Forestry Legacy program, despite 4 years of frustration.

Hosted woodland tour on Schuylkill property; achieved 8 of 10 goals on stewardship plan; hundreds of hours working in woodlot.

Though my congregation is an eclectic bunch (urban, suburban, rural, upper-middle-lower classes), they are making the connection for a theology of creation!

Speaking to high school teachers during an all-day in-service. These folks know little or nothing about forest issues. We push the deer question hard, give a tour of our 3 acre exclosure. Afterwards, one man said he'd heard a lot about the deer issue but didn't believe it until he heard us speak and showed him the difference inside and outside the exclosure.

Planting another 130 trees, building stone wall, building brush piles for animals, thinning dense areas, finding new TACF members

I'm working to get more stewardship info to young people. We have established a committee to increase our youth outreach - some ideas work; some have not.

Conducted a landowner seminar in conjunction with the NWTF. We had great speakers from DCNR, PSU, NWTF, and Pheasants Forever. We had about 30 attendees are received some great feedback on the program.

I introduced a board member of the Somerset Historical Association to the forest stewardship concept. I obtained the name of the service forester in Somerset County for him. He followed up and the Somerset Historical Association is now managing their woodlands in keeping with good forestry practices (Prior to my contact, the Association was considering just timbering without a professional forester or any input form the PA Service Forester)

I spoke to a class of 2nd graders. Read a story about trees. Gave each student an evergreen seedling and coordinated a tree planting at an inner city school in York with all second graders helping by putting a trowel of soil in planting hole.

Working as the program chairman for WOCAV where I am a charter member and director arranging programs which are beginning to reach people who have not previously been involved in any formal approach to managing their land.

BSFLA celebrated its 25th anniversary, successfully reached its \$10K scholarship goal and was awarded a 2007 NEPA Environmental Partnership Award. The Bradford county Commissions have a consulting forester and a forest stewardship plan for Mt. Pisgah County Park

Doing the Kid Connection program. It was a lot of fun seeing all the kids interested in making our bagel bird feeders and planting the white pine seedling seeds. We had a great turnout and we're looking forward to doing it again this year.

I helped Dave Scamardella, Bureau of Forestry Service Forester, control invasive species on the Kerper Tract in Fulton County. The Chambersburg Newspaper covered the work day and we made the front page with a write up and picture

Planting approximately 130 trees along riparian corridors in Bucks County; educating landowners through my job at the Conservancy; led the forestry component of the 2007 Envirothon - a program designed to cultivate a desire to learn more about our natural environment through competitive events between various high schools in PA.

Hosting the Erie Master Gardeners, teaching adults and young people on the art of grafting, able to contribute to NWPWA on tours and workshops, give advice on many oil and gas leases, most dealing with timber property, working with Rutgers Univ. on new developments, developed a procedure of getting nuts one year after graft

Through timber tax presentations I was subsequently able to give professional tax and timber sale advice, without charge, to approximately 5 individuals, including reviewing tax returns, directing landowners to a CPA, and return preparation.

I wrote a brochure "Potter County's Forested Riparian Buffers" which was distributed 200 copies through local businesses.

Our research project, begun in 2001, with 300 trees utilizing cytoplasmic male sterility in the breading of blight resistant American chestnuts continues to be challenging and rewarding. It enables us to produce chestnuts by open pollination rather than the traditional labor intensive hand pollination

This year we are testing the three types of protection tubes for trees planted in a CREP project under the Coop Ext Agency of Clearfield County at our farm.
