It is unlawful to operate any class of all-terrain vehicles including ATVs, quads, UTVs, side-by-sides, off-highway motorcycles and golf carts on any property within the ownership of The Pennsylvania State University. Horse trail riding is prohibited on all PSU approved use trails (blue). Responsible horse trail riding is permitted on PSU Stone Valley Forest roads and unmaintained paths (green). Hunting, trapping and fishing are permitted in PSU Stone Valley Forest in accordance with current Pennsylvania game and fish regulations.

Note: The majority of private roads are omitted from this map. The approved use of bicycle includes pedalcycles as defined by PA 2014 Act 154.
