

Hardwood Lumber Grading

May 17-20, 2010

(Registration from 8:30 a.m. - 9:00 a.m. on Monday, May 17)

This short course is designed to benefit anyone involved in the lumber industry who needs a basic understanding of hardwood lumber grades, including those who edge or end trim lumber, graders, sawyers, lumber buyers, rough-mill managers, and other personnel. This course will cover and explain the NHLA hardwood lumber grades and will offer extensive hands-on grading of hardwood lumber (cherry, red oak, white oak, hard maple, soft maple, hickory, and ash).

Instructors: **Lee Stover**, senior research assistant and wood products extension specialist at Penn State; **Barry Kibby**, lumber inspector with the National Hardwood Lumber Association.
