**WCO David L. Grove** was shot and killed in the line of duty on November 11, 2010 while attempting to apprehend two deer poaching suspects. On October 2, 2012, almost two years later, Christopher L. Johnson was convicted of first degree murder and subsequently sentenced to death for David's murder. WCO Grove was committed to the field of conservation law enforcement and was himself an avid hunter and fisherman. The Conservation Officers of Pennsylvania Association is currently raising funds for an endowed scholarship at the Pennsylvania State University in WCO Grove's honor.

**The WCO David L. Grove Scholarship Fund:** All proceeds from the race will benefit the WCO David L. Grove Scholarship Fund. Scholarships shall be given to a full-time undergraduate student who is of, at least, junior academic standing and majoring in Wildlife and Fisheries Science in Penn State's College of Agricultural Sciences, or to a student with a senior academic standing majoring in Wildlife Technology at Penn State Dubois. First preference shall be given to Pennsylvania residents who have demonstrated an interest in pursuing a career as a conservation officer.
